Sir,

I have the honour to state that according to Section 43(6) of the Marathwada University Act 1974, the Registrar shall submit the application and all proceedings of the Academic and Executive Council to the Senate, and the Senate shall, after such further inquiry as it may think necessary, record its resolution, which shall be forwarded to the Government together with all proceedings, for deciding to grant or reject the applications in part or in whole, I am accordingly enclosing a copy of the application alongwith two copies of Appendix 'A' showing the teaching Courses of study for under-graduate Courses which the above named homoeopathic College has requested for new affiliation from June, 1992.

The Executive Council of this University had appointed a local Inquiry Committee to report on the application. The Vice-Chancellor has accepted the recommendations of the said local Inquiry Committee with admissions of the 75 seats on certain conditions on behalf of the Academic Council, Executive Council and the Senate under the provisions of Section 11(4) of the Marathwada University Act, 1974 in the matter of affiliation and recorded his opinion that the affiliation of the above named Homoeopathic College to the University be granted initially for a period of one year w.e. from June, 1992 as per the recommendations of the Local Inquiry Committee for teaching Courses of Study mentioned in Appendix 'A' subject to the fulfilment of the conditions stated therein to the satisfaction of the University.
