Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

"Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act".

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion:-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy.

**A. Teaching Faculty:**

- The College has provided list of 12 guest faculty out of which only 01 considered eligible. Discrepancies in engagement of teachers are as below:

- a) Previous experience is not provided for the verification in following Departments: Anatomy (Reader), Pharmacy (Professor), Pathology (02 Professors), Forensic Medicine and Toxicology (Professor), Practice of Medicine (02 Readers), Surgery (Professor) and Obstetrics/Gynecology (01 Professor and 01 Reader).
- b) Dr. Priyanka Tated (Guest Reader, Surgery) - Cannot be considered as guest faculty in the Department of Surgery, as her qualification is BDS.
- ii. Only 2 consultants of modern medicines considered, as list provided of modern medicine's teachers common in Guest faculty.
- B. College Laboratory: There are deficiencies of 16 instruments/equipments as below.
- i. Crucibles with tongs 06, Electric triturator (for P.G. course) 01 not available as required in the Department of Pharmacy.
- ii. Water Bath, Electric 01, Autoclave Electric 01, Microscope with oil immersion 06 not available as required in the Department of Pathology.
- iii. Software 01 not available as required in the Department of Repertory.
- C. Miscellaneous: EPF deduction of only 8 teachers is done.
- D. Website: <http://www.dkmmhomoeocollege.com> - Teaching staff details not updated on checked on 27-7-2021.

3 After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC (MSR) Regulations, 2013, permission of the Medical Assessment and Rating Board is issued to Dakshin Kesari Muni Mishrilalji Homoeopathic Medical College, Shri. Guru Ganesh Nagar, Behind Bi-Bi-Ka Maqbara, Aurangabad Maharashtra 431004 for 100 seats in undergraduate (BHMS) course and 26 seats in post graduation course in 07 subjects namely Organon, Pharmacy, Materia Medica with 06 seats in each, Pediatrics, Psychiatry with 04 seats in each and no seats in Practice of Medicine and for the academic session year 2021-22. The College Principal is directed to fulfill the deficiencies within three months and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.

4. All admissions in Under Graduate and Post graduate course shall be through NEET/AIAPGET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State / UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of Minimum Standard Requirement Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from issue of this permission letter. Compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may

You are requested to comply with the above mentioned deficiencies within 3 months without fail and submit compliance report.

**Important Note:**

- The Continuation / Extension of Affiliation is issued for the Academic Year 2021-2022 subject to the permission of National Commission for Homoeopathy/Central Council of Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi and if the permission is declined by the said authorities this Continuation / Extension of Affiliation shall be treated as cancelled. The college is not authorized to admit the students for 1<sup>st</sup> year of the course until receipt of permission of the National Commission for Homoeopathy, New Delhi/Govt. of India/Department of AYUSH, New Delhi.
- The admission shall be done only through the Competent Authorities.
