**Sub: Application for letter of permission for functioning of Dakshin Kesari Muni Mishrilalji Homoeopathic Medical College, Shri Guru Ganesh Nagar, Behind Bi-Bi-KaMaqbara, Maharashtra, Aurangabad- 431004, for conducting BHMS course with intake of 100 seats and 42 seats for MD (Hom) in 07 PG subjects namely, Homoeopathic Philosophy, Materia Medica, Repertory, Pharmacy, Practice of Medicine, Pediatrics and Psychiatry with 06 each for the academic year 2024-25-regarding.**

Sir,

Dakshin Kesari Muni Mishrilalji Homoeopathic Medical College, Aurangabad, is functional since 1989 and has submitted an application for permission for sanction of 100 seats in BHMS Course and 42 seats for Postgraduate course in 07 PG subjects namely Homoeopathic Philosophy, Materia Medica, Repertory, Pharmacy, Practice of Medicine, Pediatrics and Psychiatry with 06 seats each for the academic year 2024-25. The College Part 1 information has been received for information on compliance to MSR 2013. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Standards Requirements to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfall.

1. Form 16 of the faculties was not uploaded of the faculties. College shall submit copy of Form 16 from traces portal of the faculties for verification.
2. Acquittance roll of guest faculty is not uploaded. College shall submit the acquittance roll of last 3 months for verification.
3. Attendance and acquittance of modern medicine consultant is not uploaded. College shall submit the copy of attendance and acquittance of modern medicine consultants for last 3 months for verification

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number, etc. Diagnosis of the case shall be recorded as per ICD 11 criteria. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.

Considering the above observations and facilities available, MARBH has decided to issue **Conditional Permission to Dakshin Kesari Muni Mishrilalji Homoeopathic Medical College, Shri Guru Ganesh Nagar, Behind Bi-Bi-Ka Maqbara, Maharashtra, Aurangabad- 431004, for conducting BHMS course with intake of 100 seats and 42 seats for MD (Hom) in 07 PG subjects namely, Homoeopathic Philosophy, Materia Medica, Repertory, Pharmacy, Practice of Medicine, Pediatrics and Psychiatry with 06 each for the academic year 2024-25.**

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 seats and 42 seats shall be treated as All India Quota. Counseling for seats under All India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

**Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.**

- vii. Required teaching staff as per Teacher: Student ratio prescribed by Central Council / Commission / University norms is fulfilled.

- viii. Admission of students is subject to availability of PG recognized teachers.
